ill and Rochelle Brownlee know the Boulder Valley. Bill's great grandfather, Robert a well-respected businessman, rancher, Montana Senator and Representative, and inductee into the Montana Cowboy

Hall of Fame - left a lasting legacy for his family when he purchased the ranch in 1906. Five generations have had the pleasure of continuing this ranching lifestyle.

"It's an incredible place," said Bill. "The ranch has provided a good living for our family and the view of the Boulder out our window is one you can't buy anymore. The wildlife, too - elk, bear, mountain lion, deer, birds, you name it - they love the ranch."

Located ten miles south of Big Timber, the 3,400-acre ranch consists of three parcels nestled against the Absaroka Beartooth Wilderness. The property includes native rangeland and irrigated hay meadows along nearly two miles of the Boulder River.

In 2020, the Brownlees began talking with MLR about conserving part of the

> ranch. "The Boulder Valley has seen its share of newcomers, but many of them recognize how special this part of Montana is and have chosen to conserve their places rather than develop them," said Bill.

"That appealed to us too."

For the Brownlees, completing the conservation easement gave them peace of mind that their ranch will remain available for agricultural production forever. "It was important to us to do what we could to keep this place the way

> it always has been, and MLR was a good fit to help us do just that," said Rochelle. "They worked with us to make sure we can still operate our

ranch the way we want under the terms of the conservation easement."

In partnership with the USDA **Natural Resources Conservation** Service's Agricultural Land Easement (ALE) program, MLR purchased two conservation easements on approximately 1,700 acres of the Brownlee Ranch in November. The easements protect the properties' agricultural viability and scenic views, and build out a growing neighborhood of conserved properties in the Boulder Valley. Most importantly, though, they help ensure that the Brownlee family's legacy in the Valley will continue long into the future.

Thank You to Our Retiring Land Stewards

As this year's monitoring season draws to a close, MLR is bidding a bittersweet farewell to eight of the team's part-time land stewards. MLR's stewardship program is about a lot more than just monitoring and compliance – it's about forming a forever partnership with landowners. The land stewards are out on the land each year building






a common goal of protecting vital open space, clean water, rich soils and grasslands, and critical wildlife habitat for the benefit of both current and future generations.


